What is this product?

Type

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

Term

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

Objectives

The objective of the sub-fund is to achieve both capital growth and stable income in the medium and long term by investing more than 50% of the net assets in bonds denominated in euros and a maximum of 30% of the net assets in prominent shares.

The sub-fund invests:

- mainly in bonds or similar fixed or floating-rate income securities, denominated in euros, as well as
- a maximum of 30% in shares listed on an official stock exchange or on another regulated market, and
- incidentally in warrants in transferable securities and in other Securities and Financial Instruments provided for by the Investment Restrictions in the full prospectus.

The sub-fund may hold liquid assets and money market instruments within legal limits.

The assets of the sub-fund may include, for a minority part, securities of issuers domiciled and/or listed in emerging countries as well as UCIs/UCITS and/or other authorised instruments in accordance with point III. A) 1.1. of the prospectus on the emerging market-oriented.

For the purpose of good portfolio management and/or hedging, the sub-fund may also use all the financial derivative instruments and other techniques/instruments set out in the Investment Restrictions in the prospectus, within the limits provided.

Benchmark: The portfolio is actively managed on a discretionary basis

without reference to a benchmark.

Intended retail investor

The sub-fund is particularly suitable for an investor wishing to participate in the performance of the EUR bond markets with a low exposure to the stock markets. The sub-fund is suitable both for individual investors wishing to invest in the equity market and for a sophisticated investor wishing to achieve predefined investment objectives. The subfund is particularly suitable for medium and long-term investments, as capital losses may occur due to stock market fluctuations.

Other information

Depositary: Banque et Caisse d'Epargne de l'Etat, Luxembourg

Dividend income: This class is a distribution class meaning that income may be distributed.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.



What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-

low risk class.

This rates the potential losses from future performance at a mediumlow level, and poor market conditions are unlikely to impact our capacity to pay you.

Be aware of currency risk. You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The sub-fund is also exposed to the following materially relevant risks that are not included in the summary risk indicator: Liquidity risk, Counterparty risk, Operational risk.

What happens if Spuerkeess Asset Management S.A. is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque et Caisse d'Epargne de l'Etat, Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 10,000 EUR is invested

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

You should be prepared to stay invested for 5 years. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
