# What is this product?

Type
This product is a share of an investment company qualifying as an un-

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

### **Objectives**

The sub-fund's objective is medium and long-term capital appreciation by investing primarily in emerging market equities and/or collective investment schemes which, in turn, invest primarily in equities and/or equivalent securities of emerging countries.

### LUX-EQUITY EMERGING MARKETS invests:

- mainly in emerging market equities, listed and closed-end undertakings for collective investment and/or open-ended undertakings for collective investment which, in turn, invest primarily in equities in emerging market countries. These Undertakings for Collective Investment may invest globally, by region or individually in emerging market countries, regardless of the size of the company;
- incidentally in cash;
- up to 25% of its net assets in other assets authorised under the Investment Restrictions in the prospectus (including other equities and UCI/UCITS than those mentioned above, bonds and money market instruments).

The sub-fund may directly and/or indirectly, within the authorised legal limits, hold liquidités.

The sub-fund may use, for the purpose of good management and/or hedging, all derivative financial instruments (such as forex, futures, options, etc.) and other techniques/instruments set out in the Investment Restrictions in the prospectus and within the limits provided.

Benchmark: The portfolio is actively managed on a discretionary basis

without reference to a benchmark.

## Intended retail investor

The sub-fund is particularly suitable for an investor with an aggressive profile wishing to participate in the performance of emerging markets. The sub-fund is particularly suitable for long-term investments, as capital losses may occur due to market fluctuations.

### Other information

Depositary: Banque et Caisse d'Epargne de l'Etat, Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one subfund do not affect the other sub-funds.



# What are the risks and what could I get in return?

### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium

risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

# What happens if Spuerkeess Asset Management S.A. is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque et Caisse d'Epargne de l'Etat, Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

# What are the costs?

#### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. # How long should I hold it and can I take money out early?

# Recommended holding period: 5 years
