## What is this product?

#### Туре

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

#### Term

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

#### Objectives

The objective of the sub-fund is to achieve medium and long-term capital growth through the investment in international equities, while allowing the investor to contribute to the energy transition. The energy transition is the main criterion in the investment policy with the aim of contributing to the decarbonisation of sectors.

LUX-EQUITY GREEN mainly invests in shares issued by companies domiciled and/or listed in OECD member states. The securities are mainly denominated in EUR and USD. The sub-fund dynamically aligns itself with the criteria recommended by the taxonomy of the European Union and applies the best practices of use on the market in order to contribute to the mitigation of climate change while taking care not to cause significant harm to other environmental objectives.

As a result, the sub-fund invests in companies that seek to improve their environmental footprint while ensuring their compliance with social criteria, which are assessed through an external ESG data provider.

The sub-fund benefits from an internal methodology, specially designed for this fund by Spuerkeess Asset Management S.A.. For this method, Spuerkeess Asset Management S.A. calls on external service providers for obtaining data. This data is then processed by the management company and the manager in accordance with the internal methodology. The management company and the fund manager are responsible for assessing the qualitative data. The selection is then made by the fund manager. Furthermore, the sub-fund has no exposure to producers of tobacco, alcohol, coal and conventional or unconventional weapons, pornography or games of chance.

The sub-fund may hold liquid assets within the authorised legal limits.

The assets of the sub-fund may include, for a minority part, securities of issuers domiciled and/or listed in emerging countries as well as UCIs/UCITS and/or other authorised instruments in accordance with point III. A) 1.1. of the emerging market-oriented prospectus. The sub-fund will not use derivative financial instruments (such as, for example, forward exchange rates, futures, options, etc.) and other techniques / instruments set out in the prospectus.

*Benchmark:* The portfolio is actively managed on a discretionary basis without reference to a benchmark.

#### Intended retail investor

The sub-fund is particularly suitable for an investor wishing to participate in the evolution of international equities, especially those of companies which the manager considers to contribute to the energy transition and which are managed according to environmental, social and governance responsibility criteria. The sub-fund is suitable both for individual investors wishing to invest in the equity market and for sophisticated investors wishing to achieve their predefined investment objectives. The sub-fund is particularly suitable for medium and long-term investments, as capital losses may occur due to stock market fluctuations.

The class M is open to investors whose shares are subscribed under a discretionary management mandate exercised by a financial intermediary.

#### Other information

Depositary: Banque et Caisse d'Epargne de l'Etat, Luxembourg

*Dividend income:* This class is a capitalisation class meaning that income is reinvested.

*Conversion right:* The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.



## What are the costs?

## How long should I hold it and can I take money out early?

## **Recommended holding period: 5 years**
