What is this product?

Type This product is a share of an investment company qualifying as an un-transferable securities (UCITS). dertaking for collective investment in transferable securities (UCITS).

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

Objectives

The objective of the sub-fund is to achieve both capital growth and stable income in the medium and long term while following an asset allocation that provides on average over the long term, a weighting of about 20% of bonds. mostly denominated in EUR and incidentally in USD as well as around 80% of European and US equities.

For the purpose of international diversification and risk diversifica-tion, LUX-PORTFOLIO - DYNAMIC invests:

- for a ratio of at least 60% in equities and similar securities, of which the majority are large caps and listed on a stock exchange in an OECD country;

- incidentally in bond or similar securities, in warrants on transferable securities, in Investment Grade money market instruments denominated in a currency of an OECD country and, within the limits provided for by the Investment Restrictions of the prospectus and in open-ended UCIs.

The sub-fund may indirectly hold cash and money market instruments which, at the time of their acquisition, have a residual maturity not exceeding twelve months.

The sub-fund's assets may include, for a minority part, securities of issuers domiciled and/or listed in emerging countries as well as UCIs/ UCITS and/or other authorised instruments in accordance with point III. A) 1.1. of the prospectus on the emerging market-oriented.

For hedging purposes, the sub-fund may also use all of the financial derivative instruments and other techniques/instruments specified in the Investment Restrictions of the prospectus within the limits provided.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

The sub-fund is particularly suitable for an investor with a more aggressive profile wishing to participate in the performance of the stock markets. The sub-fund is suitable both for individual investors wishing to invest in the equity market and for sophisticated investors wishing to achieve their investment objectives. The sub-fund is particularly suitable for medium to long term investments, as capital losses may occur due to market fluctuations.

Other information

Depositary: Banque et Caisse d'Epargne de l'Etat, Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.


Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one subfund do not affect the other sub-funds.

Average return each year

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

What happens if Spuerkeess Asset Management S.A. is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque et Caisse d'Epargne de l'Etat, Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
