What is this product?

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

Term

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

Objectives

The objective of the sub-fund is to achieve both capital growth and stable income in the medium and long term while adopting an asset allocation allowing managers to remain flexible in their approach (0% to 100% of net assets) the weighting of the various asset classes (equities, bonds, money market securities) of the sub-fund, either through direct investments or through the use of derivatives in order to achieve the desired allocation of the portfolio.

For the purpose of international diversification and risk diversification, LUX-PORTFOLIO - GLOBAL FLEXIBLE invests its assets directly and/or indirectly through derivatives (e.g. futures):

- up to 100% of the net assets in shares and/or equities similar to securities,

- up to 100% of the net assets in bonds and/or securities similar to bonds and/or in investment grade money market instruments,

- incidentally and within the limits provided for by the Investment Restrictions of the prospectus, in warrants on transferable securities and in UCIs (undertakings for collective investment) such as open.

The sub-fund may hold cash on an ancillary basis.

The sub-fund's assets may include, for a minority part, securities of issuers domiciled and/or listed in emerging countries as well as UCIs/UCITS and/or other authorised instruments in accordance with point III. A) 1.1. of the prospectus on the emerging markets-oriented.

For the purpose of sound management and/or hedging, the subfund may also use all the financial derivative instruments and other techniques/instruments set out in the Investment Restrictions of the prospectus, within the limits provided.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

The sub-fund is particularly suitable for an investor with a balanced profile wishing to participate in the stability of the bond markets, but also in the performance of the stock markets. The sub-fund is suitable both for individual investors wishing to invest in the bond and equity markets and for sophisticated investors wishing to achieve their investment objectives. The fund is particularly suitable for medium and long term investments, as capital losses may occur due to market fluctuations.

Other information

Depositary: Banque et Caisse d'Epargne de l'Etat, Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.



What happens if Spuerkeess Asset Management S.A. is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque et Caisse d'Epargne de l'Etat, Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. How long should I hold it and can I take money out early?

Recommended holding period: 5 years
