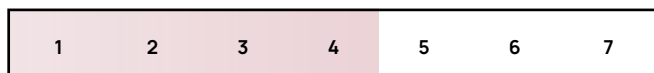
Price Evolution

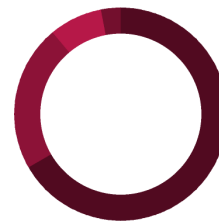

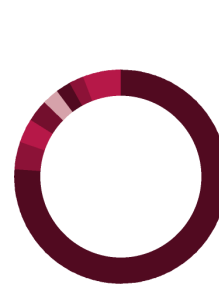
