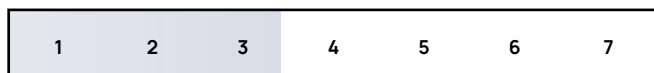
Price Evolution

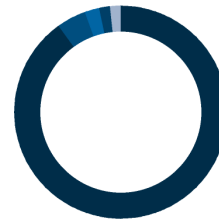
