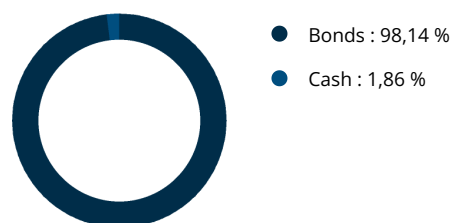

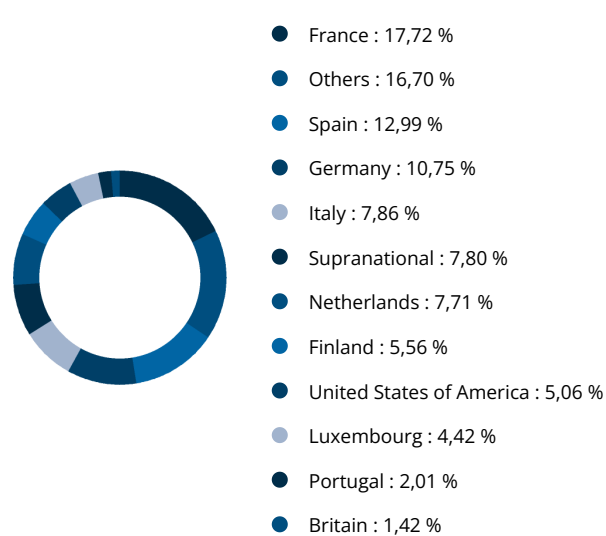

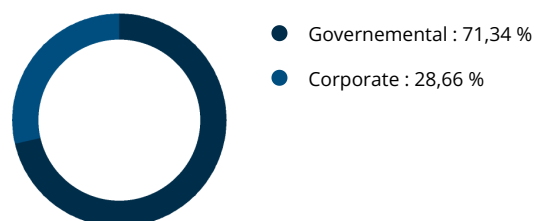
Geographical breakdown of the fixed income investments

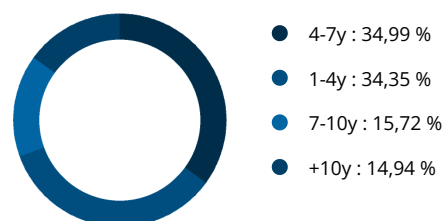
Breakdown of the fixed income investment
