



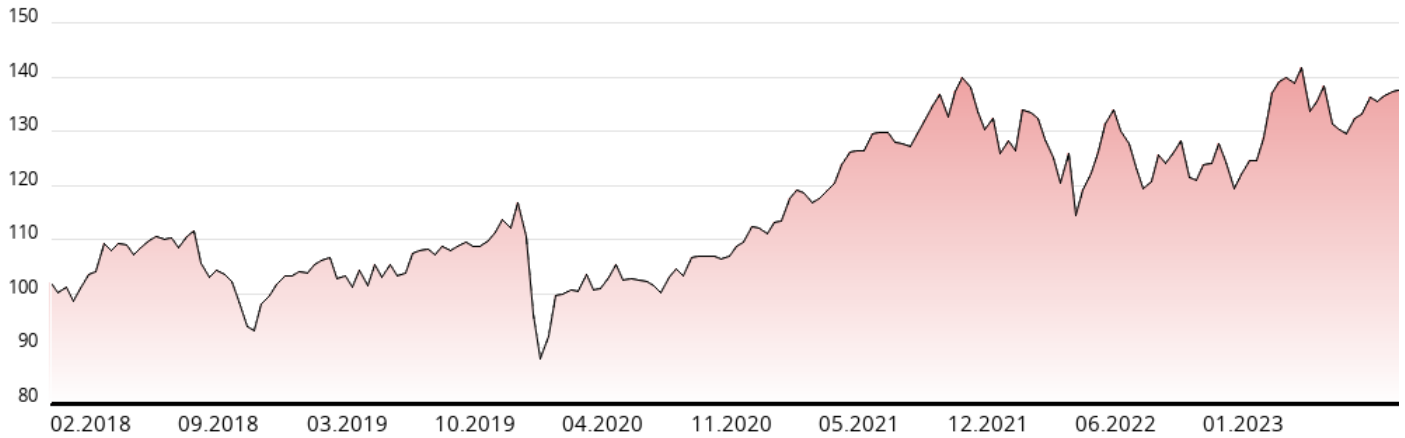

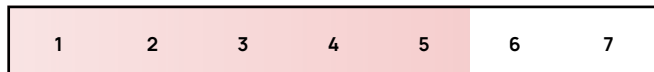
Price Evolution

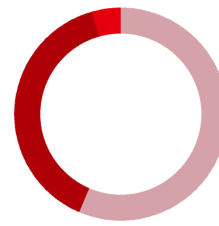

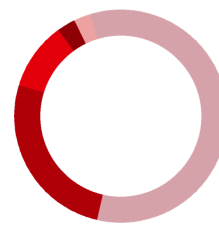

Répartition géographique du volet actions

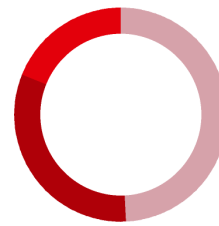
