## What is this product?

#### Type

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

#### Term

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

#### Objectives

The objective of the sub-fund is to achieve a return equal to or higher than the bond market securities of the US government, denominated in USD. In this respect, management of the Sub-fund is mainly focused on the concept of duration and yield.

The sub-fund invests:

- mainly in fixed or variable-income transferable bonds or similar securities, these being investment-grade assets denominated in US dollars;

- on an ancillary basis and within the limits provided for in the investment restrictions, as described in Chapter III.1 of the prospectus, "INVESTMENT RESTRICTIONS FOR NON-MONETARY SUB-FUNDS", in money market instruments or term deposits; on a minority basis in other Transferable Securities and Financial Instruments provided for by the investment restrictions, as described in Chapter III.1 of the prospectus - "INVESTMENT RESTRICTIONS FOR NON-MONETARY SUB-FUNDS", i.e. bonds denominated in OECD country currencies other than the US dollar.

These various investments may be made directly and/or indirectly through UCIs/UCITS. The proportion of assets invested indirectly through UCIs/UCITS may only be ancillary (up to a maximum of 49% of net assets).

A minority share of the assets (up to 33% of its net assets) may include securities of issuers domiciled and/or listed in emerging countries, as well as UCIs/UCITS and/or other instruments authorised under point III.1.A)1.1 of the prospectus with an emphasis on "emerging markets"

With regard to derivative financial instruments and other techniques/instruments, the sub-fund is limited to the conclusion of forward contracts or interest rate and/or currency swap contracts.

**Benchmark:** The portfolio is actively managed on a discretionary basis without reference to a benchmark.

#### Intended retail investor

The sub-fund is particularly suitable for investors with a medium to long-term investment horizon who are looking to benefit from the performance of the bond markets while accepting moderate volatility. Investors should be aware that minority investments in bonds domiciled and/or listed in emerging markets are not excluded. Investors whose reference currency is the EUR are exposed to fluctuations in the EUR/USD exchange rate. Investors should be prepared to accept moderate short-term capital losses due to fluctuations in bond prices. The class M is open to investors whose shares are subscribed under a discretionary management mandate exercised by a financial intermediary.

#### Other information

**Depositary:** Banque et Caisse d'Epargne de l'Etat, Luxembourg

**Dividend income:** This class is a capitalisation class meaning that income is reinvested.

**Conversion right:** The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

**Segregation:** The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

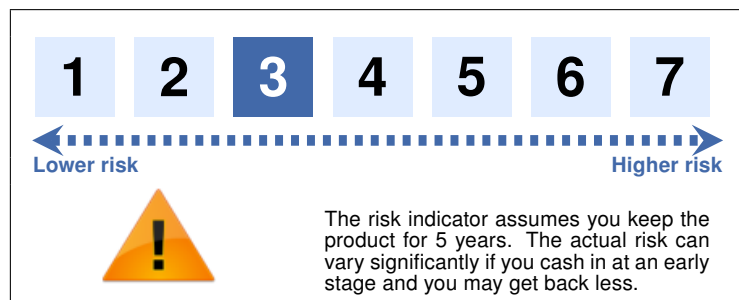

## What are the risks and what could I get in return?

### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

**Be aware of currency risk.** You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The sub-fund is also exposed to the following materially relevant risks that are not included in the summary risk indicator: Liquidity risk, Counterparty risk, Operational risk.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

## What happens if Spuerkeess Asset Management S.A. is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque et Caisse d'Epargne de l'Etat, Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario

## How long should I hold it and can I take money out early?

### Recommended holding period: 5 years

You should be prepared to stay invested for 5 years. However, you can redeem your investment without penalty at any time during this time, or hold the investment longer. Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
